Grant Funds Received 4/28/20

- Frank Phillips College acknowledges that the institution signed and returned to the Department the Certification and Agreement and the assurance that the institution has used, or intends to use, no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students.
- 2. Frank Phillips College has received \$244,218 from the Department pursuant to the institution's Certification and Agreement [for] Emergency Financial Aid Grants to Students.
- 3. The total amount of Emergency Financial Aid Grants distributed to students under Section 18004(a)(1) of the CARES Act as of the date of submission is \$244,218.
- 4. The estimated total number of students at the institution eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive Emergency Financial Aid Grants to students under Section 18004(a)(1) of the CARES Act is 252.
- 5. Each of these 252 students have received an Emergency Financial Aid Grant to students under Section 18004(a)(1) of the CARES Act.
- 6. Students who received Title IV PELL funds in the Spring 2020 semester were determined by the institution to receive Emergency Financial Aid Grants. They amount each student received was directly correlated to the amount of PELL funding they received. Tier 1 students, with 50% PELL funding for Spring 2020 received additional grant funds of \$1025.00 under Section 18004(a)(1) of the CARES Act. Tier 2 students, with less than 50% PELL funding for Spring 2020 received additional grant funds of \$794 under Section 18004(a)(1) of the CARES Act.
- 7. Guidance was provided by the institution to students concerning the Emergency Financial Aid Grants. The students were notified that the grant funds were to be used for expenses related to the disruption of campus operations due to coronavirus (including eligible expenses under a student's cost of attendance such as food, housing, course materials, technology, health care, and child care).

- 4. The Institutional costs associated with coronavirus include student meal refunds of \$49,247.24; Continued salaries and employment expense of \$68,216.23; Expansion of online courses totaling \$58,000; Equipment and software expense of \$29,410.00; Facility expenses of \$5512.10
