- **Student must be Pell eligible and must have turned in required paperwork to Student Financial Services (SFS).**
- Student will receive a book voucher for no more than \$400.00 of my Pell grant award for any term
- If the student’s Pell grant credit balance is below \$400.00, they will receive the available balance.
- Loan funds are not eligible for book voucher advances.
- If student is approved for a book voucher, the student authorizes Frank Phillips College to advance a partial Pell grant disbursement to the student prior to the first day of the class term. The amount will be posted to the student’s portal billing ledger and financial aid ledger.
- Student is responsible for full repayment to Frank Phillips College of the amount advanced as a book voucher if the student does not attend the Spring 2021 term.
