MEMORANDUM OF UNDERSTANDING Frank Phillips College and Booker ISD 2021-2022

THIS MEMORANDUM OF UNDERSTANDING (hereinafter referred to as "MOU") is made and entered into by and between the Frank Phillips College (hereinafter referred to as "College"), and Booker ISD, (hereinafter ISD), pursuant to the authority granted in compliance with section 29.908 of the Texas Education Code,

WHEREAS: Frank Phillips College and Booker ISD are authorized by state law to establish and enter into agreements for dual credit programs;

- 1. <u>Guiding Principles</u>: The Frank Phillips College and Booker ISD alliance will function on the following principles:
 - a) Establish a mutually beneficial partnership between Frank Phillips College and Booker ISD that allows a flexible and creative response to the organizational, missions, and fiscal needs of both institutions.
 - b) Provision of rigorous college readiness, dual credit, technical and early college credit courses.
 - c) Shared use of facilities including classrooms, labs, offices and libraries that reduces operating costs and promotes collaboration of students, faculty, staff, and community members in program success
 - d) Shared use of personnel including counselors, librarians, facilitators, and qualified faculty that promotes services necessary for student success.
- 2. <u>Scope of Agreement and Limitations of Authority</u>: The Scope of the Agreement and the parties agree as follows:
 - A. Governance:
 - (1). Booker ISD will:
 - a. be governed by ISD and subject to ISD's state and federal policies; and
 - b. operate within the normal operating hours of the college during a regular school day.
 - (2). Frank Phillips College:
 - a. Will have the authority to implement:
 - [1]. governance
 - [2]. staffing
 - [3]. budget
 - [4]. student assessment, curriculum and scheduling;
 - [5]. professional development;

- [6]. access to school and student data for college students with permission of the College; and,
- [7]. parent and community involvement consistent with the mission and needs of the school.
- B. <u>Awarding Credit for Courses</u>. The College will award credit for courses that have been agreed upon and have been approved. These courses shall have been evaluated and approved through the official College curriculum approval process in accordance with Texas Higher Education Coordinating Board requirements and shall be at a more advanced level than courses taught at the high school level.
- C. <u>Duties of College</u>. College shall have the following duties:
 - (1). Involve full-time faculty who are teaching in the appropriate disciplines in overseeing College course selection and implementation in the high schools;
 - (2). Ensure that course guidelines are followed;
 - (3). Apply the standards of expectation and assessment uniformly in all venues where the College offers courses;
 - (5). Designate personnel to monitor the quality of instruction in order to assure compliance with the agreed upon course outline based on the standards established by the State, applicable Accrediting Body, the College and ISD;
 - (6). Employ all instructors, including those under a teaching contract with the ISD, as Frank Phillips College faculty with the responsibilities, requirements, and benefits of an adjunct faculty member.
 - D. <u>Duties of ISD</u>. ISD shall have the following duties:
 - (1). Involve College Faculty who teach dual credit courses in design and implementation of these courses to assure that course goals enable students to master the Texas Essential Knowledge and Skills.
 - (2). Pay the salaries of instructors employed by ISD who teach in the high school;
 - (3). Ensure that all ISD high school courses are in the students' Individual Graduation Plan for Dual Credit; and
 - (4). Support the College in the required training and professional development of teachers employed by FPC as adjunct faculty.
 - E. Faculty. Faculty will be provided by College and ISD.
 - (1). Faculty provided by College:
 - a) must meet the College's academic requirements;
 - b) will teach College Dual Credit courses.
 - (2). Faculty provided by ISD:
 - a) must meet the College's academic requirements;
 - b) will teach College Dual Credit courses.
 - F. Classroom and Office Facilities.
 - (5). High School students shall have access to instructional and non-instructional resources available on the campus of the College and, in keeping with the guiding principles enumerated earlier, the high-school campus.
 - G. <u>Tuition and Fees</u>. College will waive fees for High School students enrolled in College courses based on the courses agreed upon. The student and/or the ISD or a combination of

- H. Books and Supplemental Materials.
 - (1). Only College approved textbooks, syllabi, and course outlines, applicable to the courses when taught by the College or other instructional venues, shall apply to the courses available under this MOU. Students are required to use the textbooks selected for the course, follow the syllabus, and abide by all policies established by the college.
 - (2). All textbooks and supplemental materials required for classes, as determined by the agreed upon courses that shall be provided by ISD and/or the student.
 - (3). College approved textbooks purchased by ISD may be used for the time period consistent with local College practices.
- I. <u>Recruitment and Enrollment of Students</u>.

(1). College will assist with recruitment, enrollment and retention, upon request, for all students who are qualified and wish to enroll in credit-bearing classes transcripted by Frank Phillips College.

- J. <u>Instructional Calendar</u>. The college calendar and operational hours shall take precedence over the ISD calendar and operational hours as the schedule pertains to college classes.
- K. <u>Student Code of Conduct</u>. Early College High School students, faculty and staff shall adhere to:
 - (1). Policies of ISD;
 - (2). Policies of the College; and
 - (3). Policies in the ISD Board of Trustees Policies and Administrative Procedures Manual
- L. <u>Media and Public Relations</u>. Media and public relations regarding the student will be managed according to Booker ISD and College protocols.
- 3. <u>Indemnification</u>. To the extent permitted under Texas law and without waiving any defenses including governmental immunity, each part to this MOU agrees to be responsible for its own acts of negligence, which may arise in connection with any all claims for damages, costs and expenses to person or persons and property that may arise out of or be occasioned by this MOU or any of its activities or from any act or omission of any employee or invitee of the parties of this MOU. The provisions in this paragraph are solely for the benefit of the parties to this MOU and are not intended to create or grant any rights, contractually or otherwise to any third party.
- 4. <u>Term</u>: Subject to prior termination or revocation of this MOU as provided in section 5 of this MOU, the initial term of this MOU is in full force and effect for a period of one (1) year. This MOU begins on the date of signature by both parties and continues through the initial term and any subsequent renewal terms. It may be renewed for (2) one-year terms. At least one hundred twenty (120) days before the expiration of the initial term and any subsequent renewal terms, College shall review this MOU and ISD may renew this MOU on approval of College.
- 5. <u>Right of Revocation</u>: Either party may terminate this MOU on 120 days' written notice to the other party. Termination may occur upon the breach of this MOU by one of the parties. A breach of this MOU includes, but is not limited to, a violation of the policies and rules of the College, the making of a misrepresentation or false statement by one of the parties, nonperformance of the party's duties, or the occurrence of a conflict of interest between the parties. Each party has 30

days to cure the breach. If this MOU is terminated during an academic term, students enrolled in classes under this MOU will be allowed to finish their coursework and receive appropriate course credit.

- 6. Assignment: Neither party may assign their interest in this MOU without the written permission of the other party.
- 7. Limitations of Authority:
 - A. Neither party has authority for an on behalf of the other except as provided in this MOU. No other authority, power, partnerships, use of rights are granted or implied.
 - B. This Agreement represents the entire Agreement by and between the parties and supersedes all previous letters, understanding or oral agreements between the Frank Phillips College and Booker ISD. Any representations, promises, or guarantees made but not stated in body of this Agreement are null and void and of no effect.
 - C. Neither party may make, revise, alter or otherwise diverge from the terms, conditions or policies which are subject to this Agreement without a written amendment to this Agreement.
 - D. Neither party may incur any debt, obligation expense, or liability or any kind against the other without the other's express written approval.
- 8. <u>Waiver</u>: The failure of any party hereto to exercise the rights granted them herein upon the occurrence of any of the contingencies set forth in this Agreement shall not in any event constitute a waiver of any such rights upon the occurrence of any such contingencies.
- 9. Applicable Law: This Agreement and all materials and/or issues collateral thereto shall be governed by the laws of the State of Texas applicable to contracts made and performed entirely therein.

10. Miscellaneous Provisions:

- A. Neither party shall have control over the other party with respect to its hours, times, employment, etc. However, college operational hours and calendar shall take precedence.
- B. The parties warrant that their mutual obligations shall be performed with due diligence in a safe and professional manner and in compliance with any and all applicable statues, rules and regulations. Parties to this MOU shall comply with all Federal, State, and local laws.
- C. If the Texas Higher Education Coordinating Board adopts new guidelines or Early College High School programs during the term of this MOU, the new guidelines shall prevail.

This MOU begins on the date of signature by both parties and continues through the initial term and any subsequent renewal terms. It may be renewed for (2) one-year terms. At least one hundred twenty (120) days before the expiration of the initial term and any subsequent renewal terms, College shall review this MOU and ISD may renew this MOU on approval of College.
- 5. <u>Right of Revocation</u>: Either party may terminate this MOU on 120 days' written notice to the other party. Termination may occur upon the breach of this MOU by one of the parties. WHEREAS: Frank Phillips College and Dalhart ISD are authorized by state law to establish and enter into agreements for dual credit programs;

- 1. <u>Guiding Principles</u>: The Frank Phillips College and Dalhart ISD alliance will function on the following principles:
 - a) Establish a mutually beneficial partnership between Frank Phillips College and Dalhart ISD that allows a flexible and creative response to the organizational, missions, and fiscal needs of both institutions.
 - b) Provision of rigorous college readiness, dual credit, technical and early college credit courses.
 - c) Shared use of facilities including classrooms, labs, offices and libraries that reduces operating costs and promotes collaboration of students, faculty, staff, and community members in program success
 - d) Shared use of personnel including counselors, librarians, facilitators, and qualified faculty that promotes services necessary for student success.
- 2. <u>Scope of Agreement and Limitations of Authority</u>: The Scope of the Agreement and the parties agree as follows:
 - A. <u>Governance</u>:
 - (1). Dalhart ISD will:
 - a. be governed by ISD and subject to ISD's state and federal policies; and
