Important Information for Vocational Nursing Program Applicants

KEEP THIS INFORMATION TO REMIND YOU OF NEEDED REQUIREMENTS.

1. General Admission Requirements

- Applicants must meet the general admission requirements of Frank Phillips College, including taking the college entrance test (TSI). For more information, view the [FPC Admissions page](#).

3. Texas Board of Nursing (BON) Background Check

⚠ IMPORTANT CHANGE: The Texas Board of Nursing now requires students to be board-approved **before** entering a nursing program.

- All students must undergo a DPS/FBI criminal fingerprint background check during the Spring/Summer to ensure **results are obtained before August 1, 2025**. Make sure to schedule this as soon as possible. (Watch for an email from Identigo after submitting your nursing application.)

Background Check Results:

- Clear background → Receive a **blue card** in the mail.
 - Positive criminal history → Must go through the **declaratory order process**:
 - If resolved within Operations: Receive an operations outcome letter (no charge).
 - If transferred to Enforcement: **\$150 review fee**, may take up to **90 days**.
 - **NOTE:** If you've been arrested previously, please contact Laura McIntire, Administrative Assistant of Nursing, at lmcintire@fpctx.edu.
 - Provide **blue card, operations outcome letter**, or **enforcement letter** to the FPC Nursing Office by **August 1, 2025**. Visit: www.bne.state.tx.us for more info.

4. Physical Examination

- A physical exam by your physician is required upon acceptance.

- The required form must be returned to the Nursing Department by **August 1, 2025**.
 - The physical exam cannot be dated prior to **May 17, 2025**.

5. Immunizations & TB Test

- A record of immunizations, physical exam, and TB test results **must be on file by August 1, 2025**.
- Your physician needs to fill out the Physical Exam form linked on our website: www.fpctx.edu/rnec under 'Nursing Program Printable Forms'.
- You must provide proof of immunizations through an immunization record or the physician/nurse/pharmacist who administered the immunization may sign the Immunization/Test Form for verification.
- The Immunization/Test Form is linked on our website: www.fpctx.edu/rnec under 'Nursing Program Printable Forms'.

 **Do not wait to start your immunizations!** Accepted nursing students cannot start clinical classes unless all required immunizations are complete.

6. Transcripts & GED Scores

- Submit a copy of your high school transcript, GED test scores, and/or **official transcripts from all colleges previously attended** to the Nursing Department by **August 1, 2025**.

 Applicants without transcripts or GED test scores will not be considered for acceptance.

7. HESI Admission Assessment Exam

- Make an appointment with the Nursing Department to take this test on one of the scheduled dates. Find the current testing schedule [here](#) or contact the nursing department.
 - A **\$75 testing fee** must be paid before taking the HESI (paid on the day of your scheduled test).
 - Scores older than **18 months** require retesting.
 - You must score **75% or above** on each section for entrance into the program. You may retake the test once if you do not meet the minimum scores.
 - Notification of acceptance will be sent by letter from the Director of Nursing within two weeks.

8. Advising Session

- Applicants are required to meet with FPC nursing faculty for an **advising session** prior to acceptance.
