

NOTICE OF PUBLIC HEARING ON TAX INCREASE

A tax rate of \$0.044000 per \$100 valuation has been proposed by the governing body of Frank Phillips College (Ochiltree County).

The no-new-revenue tax rate is the tax rate for the 2025 tax year that will raise the same amount of property tax revenue for Frank Phillips College (Ochiltree County) from the same properties in both the 2024 tax year and the 2025 tax year.

The voter-approval rate is the highest tax rate that Frank Phillips College (Ochiltree County) may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that Frank Phillips College (Ochiltree County) is proposing to increase property taxes for the 2025 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON August 25, 2025 AT 9:00 AM AT the Ochiltree County Courthouse, 511 S. Main St., Perryton, TX 79070.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, Frank Phillips College (Ochiltree County) is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Frank Phillips College (Ochiltree County) of Frank Phillips College (Ochiltree County) at their offices or by attending the public hearing mentioned above.

YOUR TAXES OWED UNDER ANY OF THE RATES MENTIONED ABOVE CAN BE CALCULATED AS FOLLOWS:

$$\text{Property tax amount} = (\text{tax rate}) \times (\text{taxable value of your property}) / 100$$

The 86th Texas Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.

The following table compares the taxes imposed on the average residence homestead by Frank Phillips College (Ochiltree County) last year to the taxes proposed to be imposed on the average residence

homestead by Frank Phillips College (Ochiltree County) this year.
